## 2008 GRANT AND SCHOLARSHIP AWARDS: CONTINUED

SUSIE PARKER STRINGFELLOW HEALTHCARE FUND: This past year, the Fund awarded \$612,885 in new and continuing grants to the following organizations:

- West Anniston Community Development Corporation: two-year grant to renovate four houses in west Anniston.
- Impact Alabama: grant to support the expansion of their Focus First vision screening program in Calhoun County.
- Opportunity Center: continuing grant to fund their 3R Program which enables low-income individuals to have access to refurbished durable medical equipment from van lifts to walkers at no cost.
- City of Anniston: grant to test, identify and remediate the presence of lead-based paint in homes.
- Anniston High School: grant that matched \$100,000 in public contributions to purchase textbooks, equipment and materials to maintain accreditation of the health sciences and other career tech programs.
- 2nd Chance: grant to purchase a computer, upgrade software, add wireless capabilities and purchase supplies in support of their mission to address domestic violence.
- Family Links: continuing grant to fund the nationally accredited Parent Empowering All Kids, which teaches parents long-term solutions in addressing minor to major behavioral issues.
- Coosa Valley Youth Services: grant to purchase four defibrillators.
- Concern for Children: two-year funding to implement an Internet safety program for parents, children, teachers and law enforcement personnel. The program will address cyber bullying, predation safety, identity theft and piracy.
- Habitat for Humanity of Calhoun County: continuing three-year grant for the construction of three houses. The award is matched dollar-for-dollar to build three additional houses during the same three-year timeframe.
- Daybreak Crisis Recovery Center: grant to hire a part-time licensed crisis counselor to provide free counseling services for victims of rape.
- Alabama Baptist Children's Home & Family Ministries: continuing grant to build and equip a play therapy room at their home in Oxford.
- Wellborn Elementary School: continuing three-year grant to grade and level the playground and install new equipment.
- YMCA of Calhoun County: three-year grant to support the capital campaign to improve and expand access to health and fitness programs.

Mrs. London is a retired nurse and currently volunteers as a minister to cancer patients in various medical settings. She is an active member of Anniston First United Methodist Church.

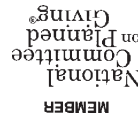
